This is why the Global Junior Challenge Jury will be composed by Italian and international schoolteachers and headmasters. The jury will evaluate about 30 projects in the week of **September 14-21, 2015**.

In particular, each jury member will receive an Excel file with the list of projects that need to be evaluated (identified by an ID number). The link is <http://www.gjc.it/2015/it/cerca-progetti> <sup>[1]</sup>. Projects will be evaluated on a range of criteria and will receive a score of 1 to 10 for each parameter. The total score will determine the overall final score for the project.

There will be eight project categories and the jury members will be assigned to the various categories on the basis of their skills and curriculum.
